



RULES OF PROCEDURE OF THE "UNSUPERVISED" POOL

"INSTANT NATURE" CAMPSITE & UNUSUAL ACCOMMODATION IN SAÂCY-SUR-MARNE

ARTICLE 1: ACCESS AND SCHEDULING

- * Access to the swimming pool is reserved exclusively for guests staying and registered at the INSTANT campsite NATURE. DAY VISITORS ARE NOT ALLOWED ACCESS TO THE POOL.
- * Opening and closing times of the swimming pool are displayed at the entrance. It is imperative that they be scrupulously observed. The management reserves the right to modify these schedules in case of necessity (maintenance, meteorological conditions, etc.), without notice.
- * Access to the swimming pool outside opening hours is strictly prohibited.
- * Pets are not allowed in the pool area.

ARTICLE 2: CONDITIONS OF USE AND SAFETY

- * Due to the lack of monitoring, each user is responsible for their own safety and that of their caregivers, including children, who are under the full responsibility of adults.
- * Children under 10 years of age and/or unable to swim must be accompanied and supervised by a responsible adult at all times. This adult should be in close proximity to the child and be able to intervene quickly.
- * It is the responsibility of each user to ensure their own fitness for swimming. People with health problems (epilepsy, heart problems, etc.) should take all necessary precautions and, if necessary, refrain from swimming alone.
- * Caution and basic safety rules are required to avoid accidents. In particular, the following shall be prohibited:
 - Running and violent games around and in the pool.
 - Diving (unless otherwise specified and in authorized areas).
 - Stampeding and pushing others into the water.
 - Use of unsuitable or potentially hazardous material.
 - Balloons, mattresses and other voluminous floating objects in case of high crowds.
 - Screams that may be inconvenient to other campers, neighbors or the vicinity of the campsite.
- * Swimwear is mandatory (swimwear, burkinis, dresses, swimwear prohibited for reasons of hygiene).
- * It is mandatory to shower before entering the water and passing through the foot bath.
- * It is forbidden to spit, urinate or blow your nose in the water or on the beaches of the swimming pool.
- * People with open wounds, dressings, or contagious skin conditions are not allowed to bathe unless justified by a certificate of non-contagion.
- * It is forbidden to introduce into the enclosure of the swimming pool glass objects, sharps or any other object that may present a danger to bathers and equipment.
- * It is forbidden to eat and drink in the water of the swimming pool.
- * Smoking or vaping is strictly prohibited in the pool area.

ARTICLE 3: LIABILITY

- * The management of the campsite INSTANT NATURE declines any responsibility in case of theft, accident, drowning, injury or any other damage occurring in the area of the swimming pool, taking into account its unsupervised nature.
- * The use of the swimming pool is under the sole responsibility of the users.
- * It is the responsibility of parents or guardians to ensure the safety of children in their care.

ARTICLE 4: EQUIPMENT AND FACILITIES

- * Materials provided (ladders, etc.) should be used as intended. Any voluntary degradation will be charged.
- * It is forbidden to move or modify the layout of the equipment of the swimming pool.

ARTICLE 5: NON-COMPLIANCE WITH THE REGULATIONS

- * Failure to comply with these Regulations may result in temporary or permanent exclusion from access to the pool, without any reimbursement.
- * Management reserves the right to take any action it deems necessary in the event of non-compliance with safety rules or inappropriate behavior.

ARTICLE 6: GENERAL PROVISIONS

- * Management reserves the right to amend these Rules of Procedure as necessary.
- * In case of problem or incident, please contact the reception of the campsite.
